#### **IMPORTANT NOTES**

**All Fees and Payments** are processed on line through the FACTS Management site. Families are required to set up auto payments in their account. Any exceptions must be approved by our Finance Director.

Parish Subsidy Form for 2020-2021 is due to your pastor March 15, 2020

Resource Fees for 2020-2021 are due June 1, 2020 (non-refundable)

First Tuition Payment for 2020-2021 is due July 1, 2020 (non-refundable)

Second tuition Payment for 2020-2021 is due August 1, 2020 (non-refundable)

**Assessment Fee** is an obligation for the year even if the family withdraws prior to the end of the school year. This fee is to help offset the expenses of maintaining the building and grounds of the school campus.

Early Withdrawal Policy: Records cannot be transferred until all obligations are met.

- First 2 months tuition (based on 10 month plan)
- Any outstanding tuition and fee balance through the end of the tri-mester
- Full Assessment Fee
